for a letter of support from the Northern Nevada Water Planning Commission

("NNWPC")

SUMMARY

The United States Department of the Interior, Bureau of Reclamation ("BOR") and four non-Federal cost-share partner agencies have proposed to jointly sponsor the preparation of a basin study for the Truckee River basin. The cost-share partners are: Tahoe Regional Planning Agency, Placer County Water Agency, Truckee Meadows Water Authority, and Truckee River Flood Management Authority.

In the Truckee Basin Study ("Study"), BOR and its study partners will estimate the existing and projected water demands imposed by a growing population and compare those demands to existing supplies and potential future supplies. The Study will also incorporate future climate change assessments which will provide general trends in the region's future climate based on anticipated changes in temperatures and precipitation. From these assessments, the Study will develop estimates of changes in frequency, duration and intensity of severe storm events which may result in flooding in the Truckee River watershed. The Study will evaluate potential imbalances in demand and supply to identify feasible structural and non-structural options for resolving those imbalances. Utilizing broad stakeholder involvement and consensus, the Study partners will provide a spectrum of recommendations incorporating adaptive strategies to respond to potential climate change effects and other uncertainties.

BOR has prepared a Plan of Study ("POS"), which the Study partners have agreed to. The POS is a guide to how the Study will be prepared and summarizes the study management structure, describes planning approaches, activities to be accomplished, milestones, and a schedule to complete the Study. The POS, which is attached to a Memorandum of Agreement among the cost-share partners and presently in the process of being executed, may be amended by mutual consent of all the partners.

BACKGROUND

The preparation of a basin study is an authorized program of the Secure Water Act (P.L. 111-11). The basin study program is specifically intended to assess the risk of climate change to water resources in the west's major river basins. BOR is the lead Federal agency for preparing the basin study.

The Secure Water Act specifically identifies eight major Reclamation basins that are proposed for a basin study; the Truckee River is one of the eight river basins listed. The

intent of the basin study program is to ensure, to the maximum extent possible, that strategies are developed at watershed and aquifer scales to address potential climate change effects on water supplies and demands. The basin study is intended to assist water management agencies to incorporate the potential risk of water shortages, conflicts, and other impacts to water users dependent upon the Truckee River, into their management and decision processes.

Staff recommends that the NNWPC accept the report on the Truckee River Basin Study and authorize the Chairman to sign and send the attached letter of support for the Study.

SUMMARY

The SWPCC is seeking a letter of support from the NNWPC (attached) for a Grant Application being submitted to NDEP for Clean Water Act Section 319(h) Grant Funding as part of the Non-Point Source Program for watershed awareness and improvement projects.

PREVIOUS ACTION

FISCAL IMPACT

DISCUSSION

The State of Nevada's 319(h) Non-Point Source Grant Program has issued requests for proposals for projects to promote water quality protection. The SWPCC desires to pursue grant funding to develop a watershed fold-out map for distribution and signage for some creek crossings in the Truckee Meadows.

Watershed management as it relates to water quality is a responsibility outlined in the interlocal agreement between Washoe County and the Cities of Reno and Sparks. Condition assessments of the creeks that flow into the Truckee River have been conducted annually since 2005. Using the information obtained, web-based tools have been created, such as the Watershed Mapserver (GIS-based) and the Watershed Maptool, that serve as resources for educators. This proposal would include: development of a fold-out map of the Truckee River Watershed with messaging and website references and signage at selected creek crossings. The intent is to further educate the community about the watershed, promoting protection of our water resources and reduction of non-point source pollution. The project would be administered through the City of Reno in coordination with the City of Sparks and Washoe County.

RECOMMENDATION

Staff recommends that the Commission authorize the Chairman to sign a letter of support for the SWPCC's application to NDEP for Clean Water Act Section 319(h) Grant Funding.

SUBJECT: Report on amendments to the Open Meeting Law made by the 2011 Nevada

Legislature.

Two Nevada Open Meeting Law ("OML") bills were passed the 2011 Legislature: <u>AB59</u>, requested by the Attorney General, and <u>AB257</u>, requested by Assemblymen Carpenter and Ellison. In the electronic version of this Report, the full text of each bill in final form, as enrolled, is available by clicking on the above links. A summary of the amendments that affect the NNWPC is provided below. Some of the required changes can be noted in various revisions to the form of the agenda for the September 7, 2011 NNWPC meeting.

SUMMARY

- 1) The amendments to the OML enacted by AB 257 affect only the public comment period requirements, and provide that comments by the general public must be taken:
- (I) At the beginning of the agenda (before any action is taken), and again before adjournment. [This has always been the general practice of the NNWPC.] This option allows, but does not require, that comments be taken during the meeting on action items; **or**
- (II) After each action item is discussed, but before action is taken on that item. If this option alone is used, public comment must be allowed, at some time before adjournment, on any subject matter not specifically included on the agenda as an action item.

Nothing in the existing or amended OML prevents a public body from doing both -- providing public comment periods and allowing public comment on action items. That has and will continue to be the procedure recommended by counsel and followed by the NNWPC .

- 2) A list of the amendments enacted by AB 59 is set forth below. Three changes that affect the content of the agenda are discussed following the list.
 - If the Attorney General finds a violation of the OML, the public body must include an item on its next agenda acknowledging the finding of the violation. This acknowledgement does not constitute an admission of wrongdoing in subsequent legal proceedings.
 - The Attorney General is given the power to issue subpoenas to investigate violations of the OML, and failure to comply with a subpoena is a misdemeanor.

- Any administrative or advisory body that is created by a resolution or other formal designation of a body created by a statute of this state, e.g., the NNWPC, is a public body for the purposes of the OML.
- In addition to existing criminal penalties for violations of the OML, the Attorney General may recover a civil penalty not to exceed \$500 from each member of a public body who attends a meeting where action is taken in violation of the OML, and who participates in such action with knowledge of the violation. (Emphasis added.) Any such penalty must be recovered through a civil action brought, in the name of the State of Nevada, within one year from the date of violation.

Any restriction on public comment **must be reasonable and stated on the meeting notice** (agenda). A public body may restrict time, place, and manner of public comment, but may not restrict comment based on viewpoint. That is consistent with the idea that public entity meetings are limited public forums instead of open public forums where almost no restrictions on speech will survive legal challenges.

The agenda must provide notice that: "Items on the agenda may be taken out of order; the public body may combine two or more agenda items for consideration; and the public body may remove an item from the agenda or delay discussion relating to an item on the agenda at any time." The revised NNWPC agenda form addresses those requirements.

Finally, the list of items on which action may be taken must denote that action may be taken on those items by **placing the term "for possible action" next to the action item**. The revised NNWPC agenda form also complies with this requirement.

The above amendments became effective on July 1, 2011. The current and all future agendas must be in compliance with the new requirements. Legal counsel will be available at the September 7 NNWPC meeting to answer any questions and address any concerns.

SUBJECT: Update on the Truckee Meadows Regional Planning Agency ("TMRPA")

Regional Data Development Project and possible direction to staff

SUMMARY

In July 2011, staff started working approximately 16 hours a week at the TMRPA offices as per the Interlocal Agreement ("ILA") between the Western Regional Water Commission ("WRWC") and the Regional Planning Governing Board ("RPGB") for the Regional Data Development and Analytical Program. The scope of work for the current quarter includes the following tasks.

- Assist TMRPA staff and peer review team in the development of the population and employment model, specifically with water-related elements
- Help TMRPA staff to understand the linkages between future land use development and planning for water and wastewater infrastructure
- Assist with Housing and Urban Development ("HUD") grant application

Activities to date include two workshops with TMRPA staff, peer review team and local government planners and model users. Staff also coordinated a workshop with water and wastewater utility technical staff to explore possible refinement of the existing water-related model input factor.

The short term goal concerning water-related factors is to improve on the existing "proximity to water infrastructure" factor for use in the initial model runs to be conducted in October. It appears that a parcel's proximity to water and/or sewer infrastructure should function adequately for initial model runs provided utility technical staff review infrastructure maps and identify specific infrastructure or areas that should be weighted differently because of capacity constraints. Over the long term, more work will be necessary to better define capacity constraints and develop efficient methods to incorporate capacity constraints into the model input factors.

In addition, staff is working with TMRPA staff and Stantec to explore the incorporation of the Regional Water Balance model, developed by ECO:LOGIC for the Regional Water Plan. The five planning areas identified in the Water Balance model may help to define service areas having infrastructure or resource constraints that can be weighted and used to further develop the model input factors.

BACKGROUND

In March 2011, the WRWC approved an ILA with the RPGB for partial funding of the Regional Data Development and Analytical Program, a TMRPA project involving multiple phases and stakeholders. The ILA provides for funding and in-kind services, including as much as 60 percent of the WRWC Program Manager's time in Fiscal Years 2011-2012 and 2012-2013.

The data base and scenario planning and modeling tools to be developed by the project will, with the addition of appropriate supplemental elements related to water, facilitate the effective coordination of land use and water resource planning, and assist in the planning and administration required by the Western Regional Water Commission Act, and the implementation of the Comprehensive Regional Water Management Plan.

RECOMMENDATION

Staff recommends that the NNWPC accept this report on the TMRPA project and provide direction as appropriate.
