MINUTES NORTHERN NEVADA WATER PLANNING COMMISSION

Wednesday, May 7, 2014, 1:30 p.m.

The regular meeting of the Northern Nevada Water Planning Commission ("NNWPC") was held in the Washoe County Commission Chambers, 1001 East Ninth Street, Reno, Nevada and conducted the following business:

The meeting was called to order by Chairman Drinkwater at 1:30 p.m.

1. Roll Call and Determination of Presence of a Quorum

3. Approval of the Agenda (For Possible Action)

COMMISSIONER SOLARO MADE A MOTION TO APPROVE THE AGENDA, SECONDED BY COMMISSIONER PRICE. THE MOTION CARRIED UNANIMOUSLY WITH EIGHT (8) MEMBERS PRESENT.

4. Approval of Minutes from the April 2, 2014, Meeting (For Possible Action)

COMMISSIONER ERWIN MADE A MOTION TO APPROVE THE APRIL 2, 2014, MINUTES, SECONDED BY COMMISSIONER FLANSBERG. THE MOTION CARRIED UNANIMOUSLY WITH EIGHT (9) MEMBERS PRESENT.

5. Review draft Western Regional Water Commission ("WRWC") tentative budget for Fiscal Year 2014 – 2015; discussion, possible direction to staff, and possible recommendation to the WRWC – Jim Smitherman, WRWC/NNWPC Water Resources Program Manager. (For Possible Action)

Mr. Smitherman reviewed information included in the staff report regarding the budget for Fiscal Year 2014 – 2015 as follows: The estimated surcharge revenue is a little over 1.5 million dollars, which is a three percent increase over last year. The staff services line item is increased to \$525,500 to include the County overhead. The non-staff operating services are down from about \$103,000 to \$88,000. The total budget amount is almost 2.8 million dollars. The projected cash balance at the end of Fiscal Year 2014 - 2015 will be about \$300,000, which is in compliance with the reserve policy.

COMMISSIONER KRUTZ MADE A MOTION TO RECOMMEND APPROVAL OF THE FISCAL YEAR 2014 - 2015 BUDGET TO THE WRWC, SECONDED BY COMMISSIONER FLANSBERG. THE MOTION CARRIED UNANIMOUSLY WITH EIGHT (8) MEMBERS PRESENT.

6. Discussion regarding a request by the City of Reno for partial funding of a watershed improvement project to reduce storm water flows to the Highland Canal and improve the quality of such flows to the Truckee River; possible direction to staff, and possible recommendation to the WRWC to approve funding in an amount not to exceed \$250,000 for the project from the Regional Water Management Fund ("RWMF") – Terri Svetich, P.E., Engineering Manager, City of Reno and Glen Daily, P.E., Associate Civil Engineer, City of Reno. (For Possible Action)

Ms. Svetich presented information on the history of the Highland Canal. TMWA has been paying for the design and have said they will take care of the permitting as well. The Truckee River Fund is going to provide the majority of the construction monies for this project. Ms. Svetich stated what they are asking for from the RWMF is the match for the Truckee River Fund.

[Commissioner Ball arrived at 1:40 p.m.]

John Rhodes, Legal Counsel, stated there was a question at the last NNWPC meeting as to whether paying for construction costs for infrastructure like this would be an allowable expenditure from the RWMF. Mr. Rhodes has since done a detailed analysis of the Western Regional Water Commission Act and the WRWC Joint Powers Agreement, and stated his conclusion is that this specific project, as it is presented, does aid in the implementation of the Comprehensive Plan in that it assists in implementing goals, policies, provisions, and elements in the Plan relating to municipal water supply, quality of surface water, storm water drainage, and control of source and non-source pollution. Mr. Rhodes stated his opinion is that this is an appropriate and allowable expenditure for this particular project.

Commissioner Krutz questioned Mr. Smitherman about this Commission's history of providing construction funds. Mr. Smitherman stated this would be the first project that the NNWPC would recommend approval for expenditures on a capital project.

Chris Anderson, Washoe County Health District, stated he is a non-voting member of the NNWPC and after some discussion at the Washoe County Health District, they feel this is a project worthy of the NNWPC's support. He added that it does address many of the components consistent with the Water Management Plan including watershed management, storm water quality, and water supply and quality. Mr. Anderson stated this project will help the water supply and quality to Chalk Bluff, which provides forty-nine percent of the water supply and treatment to the TMWA service area.

Commissioner Solaro stated he does not feel he can vote on this item because this is something that would benefit him personally as a department head of Washoe County. Commissioner Solaro stated he would abstain from this vote.

Chairman Drinkwater stated the project is being presented today in an urgent manner – this is something that we need to take action on quickly in order to prevent possible water pollution. That statement is belied by the inaction of both Washoe County and the City of Reno and the utility for the better part of two decades. Chairman Drinkwater referred to Ms. Svetich's statement that the Highland Canal was never meant to convey storm water. Chairman Drinkwater stated he would argue that the Highland Canal was originally an irrigation ditch and that perhaps it was never intended to convey influent to a water treatment plant. Chairman Drinkwater also asked what condition the Highland Canal was in when TMWA took ownership. Chairman Drinkwater stated every entity has a Capital Improvement Program ("CIP") and in that CIP all of the projects are risk ranked against likelihood of failure or the need and then the impact if that need is not met. If the NNWPC is going to make a habit of making recommendations to the WRWC to fund construction, there needs to be a more formal process

where they can see the needs of the community and make the appropriate decision and not just fund the first thing to the table.

Commissioner Flansberg stated it is correct that when the City of Reno does their capital programming they are looking at those with the highest risk and those areas with the greatest concerns. Commissioner Flansberg stated this body is not being asked to fund the entire project and they have looked into other funding sources. Through the Truckee River Fund and through the money that TMWA has spent, that portion has gone in so this request is asking for the match funding that is needed for the Truckee River Funds. Commissioner Flansberg stated this project has been worked on for several years and there have been other projects that have been implemented earlier on. There is still an issue during high flows where water can get into the Highland Canal and cause problems that TMWA could identify here.

Glen Daily, City of Reno, stated it is his understanding that the Highland Canal was originally constructed as a water supply canal. It served the Highland Reservoir, which now serves as a storage facility, and was the first domestic water supply system for Reno and Sparks. At that time the urbanized area of Reno and Sparks sat below the Reservoir and it was a gravity system. Mr. Daily stated he does not believe it was originally constructed as an irrigation facility.

COMMISSIONER ERWIN MADE A MOTION TO RECOMMEND TO THE WRWC TO APPROVE FUNDING IN AN AMOUNT NOT TO EXCEED \$250,000 TO FUND THIS PROJECT FOR FISCAL YEAR 2014 – 2015, SECONDED BY COMMISSIONER DeMARTINI.

Commissioner Price stated he sees this as a twenty-five percent match on a grant and it is based on an engineer's estimate. He added that if the twenty-five percent was based on the actual cost, he would be willing to support it. Commissioner Price requested that the motion be changed from not to exceed \$250,000 to twenty-five percent of the actual cost.

Commissioner Erwin asked Ms. Svetich and Ron Penrose if Commissioner Price's request would work for the project. Ms. Svetich stated they need to demonstrate that they have the twenty-five percent match to the Truckee River Fund and at the moment \$250,000 would be the required match.

Mr. Rhodes stated the motion has to include not to exceed \$250,000 because that is the way the agenda item is written. The motion could state twenty-five percent of actual cost but not to exceed \$250,000.

Ron Penrose, Project Manager for TMWA, stated the way the Truckee River Fund works is that in order for dollars to be released from the Fund to the grantee, they must demonstrate that they have the twenty-five percent match. Mr. Penrose suggested that the motion stay as stated for \$250,000, knowing that there may be some money coming back if the construction costs are less.

Commissioner Erwin asked for clarification of Commissioner Price's request. Commissioner Price stated he does not want to fund a construction project but he can support a grant match. Mr. Penrose stated there is a danger that the Fund Advisors or the Fund itself will not release the match money if the twenty-five percent, based on the estimated cost, is not provided.

Commissioner Erwin stated he would let the motion stand.

THE MOTION CARRIED WITH FIVE (5) IN FAVOR, THREE (3) OPPOSITIONS BY COMMISSIONERS DRINKWATER, KRUTZ, AND PRICE, AND ONE (1) ABSTENTION BY COMMISSIONER SOLARO.

Mr. Rhodes stated for the record that Legal Counsel did advise Commissioner Solaro that he was not required to abstain, but has the right to do so.

7. Report on the Truckee Meadows Regional Planning Agency ("TMRPA") parcel-based population and employment modeling project – Jim Smitherman.

Mr. Smitherman stated the first phase of this project is complete. The core of the project that was completed about a year ago was the completion of the population and employment model. Mr. Smitherman stated there has been interest in the project and co-funding by the Regional Transportation Commission ("RTC"). There has recently been interest in cooperation expressed by the Washoe County School District in doing some of their school forecasting. Mr. Smitherman stated they are now working on developing a request for qualifications to retain technical assistance for scenario planning. The value of the upcoming planning effort would be to have the ability to forecast or predict what water demands might be on a parcel level. Mr. Smitherman stated the end game for the project would be to get the model populated to the point where they can run water and wastewater flow predictions and also be able to run scenarios of what the growth rates might be in the area.

Commissioner Price asked if the original intent of the RTC portion is complete. Mr. Smitherman stated the RTC's portion was the delivery of the results of the population employment model last summer for their transportation planning. Whether or not the RTC is interested in participating in something like residential land needs analysis remains to be seen.

Commissioner Price asked if there was an original cost estimate and completion date for this project, other than the NNWPC contract. Mr. Smitherman stated he has not seen an original cost estimate or completion date for this project. It was more conceptual than that, envisioned as a valuable tool for both regional land use planning and regional water planning, and it has evolved since then.

Commissioner DeMartini asked if there are provisions in the model to automatically adjust as new occupancy permits are issued. Mr. Smitherman stated it does not have the ability to do dynamic adjustments along the way.

Commissioner Erwin asked about what additional technical assistance would be needed if much of that technical assistance resides in the various agencies represented here. Mr. Smitherman stated he believes it is the methodology to conduct the needs assessment, for which a consulting firm out of the Northwest was used to do the industrial analysis. Mr. Smitherman further commented that whether or not we have the expertise is a question worth asking and pursuing. Commissioner Erwin asked that when Mr. Smitherman next meets with his team that they talk about that. Commissioner Erwin stated he would like to see the scope refined so that work is not being duplicated that is already being undertaken by the jurisdictions.

8. Report on the Bureau of Reclamation's Truckee River basin study – Jim Smitherman.

[Commissioner Price left at 2:22 p.m.]

Mr. Smitherman stated he spoke with the project manager for an update on this item. He added that last June and August there were two web-based seminars held with interested parties and stakeholders where they gathered information regarding water supply and water demand. Mr. Smitherman said after the water demand workshop, they circulated storylines that they wanted comments on that they will be using for projections or scenarios. There was to be another web-based workshop dealing with risk and reliability analysis sometime this quarter that has been postponed until later in the year. Mr. Smitherman stated Arlan Nickel, Project Manager with the Bureau of Reclamation, said the next thing we could expect to see would be a mid-summer workshop where they can present the information on the data they have compiled so far on water demand, water supply, and the scenarios.

9. Report on the pending consolidation of Washoe County's Water Utility and the South Truckee Meadows General Improvement District with the Truckee Meadows Water Authority ("TMWA") – Jim Smitherman.

Mr. Smitherman stated things are moving forward and meetings among the three water utilities, based on the actions of their respective boards, are favorable in moving forward with the consolidation. Personnel transfers and benefits are among the topics being discussed.

Commissioner Solaro stated on March 19 TMWA and the Board of County Commissioners met in a joint meeting and gave management the go ahead to enact this merger by the end of this calendar year.

10. Program Manager's Report – Jim Smitherman.

Mr. Smitherman stated the staff report includes items that are typically present in the Program Manager's Report and offered to answer any questions.

11. Discussion regarding possible agenda items for the June 4, 1014, NNWPC meeting, and other future meetings, and possible direction to staff – Jim Smitherman. (For Possible Action)

Mr. Smitherman reviewed possible future agenda items, which include: a report back on the WRWC budget hearing and contract renewals for on-going projects; approval of the Routine Operating Budget; contract for the Washoe ET Project for additional weather stations; contract for the Nevada Landscape Association's Certified Landscape Technician Program; and long-term project funding projections.

Commissioner Erwin stated the update of the Regional Water Management Plan is due January 2016 and requested information at a future meeting on what the scope or magnitude of required revisions in the Plan will be and the amount of lead time that will be needed to meet that calendar.

12. Commission Comments

Chairman Drinkwater expressed appreciation that his request to update the Commission Membership on the web page was handled very promptly.

13. Staff Comments

Mr. Smitherman stated the WRWC did act favorably on the request from the Truckee River Flood Management Authority ("TRFMA") to create a seat on this panel for representation and they appointed Danielle Henderson.

14. Public Comment

Mr. Penrose stated TMWA is conducting an open house of the Chalk Bluff Treatment Facility tonight as part of National Drinking Water Week. Mr. Penrose stated they could do a personalized tour of the Plant and a field trip to look at the Highland Canal system in the future for the NNWPC and staff.

Commissioner Erwin recommended a personalized tour for the Glendale Plant as well because the operation control room has been updated.

SUMMARY

In 2009, the WRWC authorized the Water Resources Program Manager to approve invoices submitted to the WRWC; to approve in-budget expenditures from the Regional Water Management Fund ("RWMF") not to exceed \$25,000 per project upon recommendation of the Northern Nevada Water Planning Commission ("NNWPC"); and to sign contracts for such expenditures. (See attached Resolution No. 3.) To maintain consistency with the WRWC's delegation of authority and the NNWPC's actions in previous years, staff has prepared the attached routine operating budget for non-staff services, which, with NNWPC approval, will allow the Program Manager to procure such services and supplies in fiscal year ("FY") 2014/2015 without placing individual items for each expenditure on future NNWPC agendas.

BACKGROUND

The NNWPC reviewed and approved the FY 2014/2015 routine operating budget for non-staff services on May 7, 2014, and recommended it to the WRWC for adoption as part of the FY 2014/2015 tentative budget. The WRWC adopted the FY 2014/2015 budget on May 15, 2014.

At a regular meeting held December 12, 2008, the WRWC voted "to designate Jim Smitherman, WRWC Program Manager, as the person authorized to approve invoices submitted to the WRWC, and approve in-budget expenditures from the RWMF not to exceed \$25,000 upon recommendation of the NNWPC, including the authority to authorize routine operational expenditures."

On January 9, 2009, the WRWC adopted Resolution No. 3 to formalize and clarify its December 12, 2008, action designating the Program Manager as the person authorized to approve invoices submitted to the WRWC; and also authorize the Program Manager to approve in-budget expenditures from the RWMF not to exceed \$25,000 upon recommendation of the NNWPC and to sign contracts for the same.

Regional Water Management Fund ("RWMF") for Fiscal Year 2014/2015: A) possible recommendation to the Western Regional Water Commission ("WRWC") to approve a First Amendment to the Interlocal Agreement with the Desert Research Institute ("DRI") to add \$29,050 in funding for upgrades and installation of weather stations; and, B) authorize the expenditure by staff of up to \$10,950 for services provided by other vendors for work related to the installation

of weather stations.

SUMMARY

The Desert Research Institute ("DRI") currently provides maintenance and data acquisition for two weather stations associated with the Washoe Evapotranspiration Project (the "Project"). In addition, staff has identified six weather stations that are part of the Washoe County Community Services Department ("CSD") inventory that are currently not in use. CSD has agreed to provide the use of the stations as part of a collaborative effort with DRI to further enhance the Project.

At the Northern Nevada Water Planning Commission ("NNWPC") meeting on March 5, 2014, the NNWPC approved a motion to augment the FY2014/2015 budget for the Project by \$40,000 to fund the upgrades and installation of additional weather stations. Staff is requesting the NNWPC to recommend that the WRWC approve a First Amendment to the Interlocal Agreement with DRI to add an amount not to exceed \$29,050 for that purpose. In addition, staff is seeking authorization from the NNWPC for the Water Resources Program Manager to procure services from other vendors for work related to the installation of the weather stations, in an amount not to exceed \$10,950.

BACKGROUND

During the October 2, 2013 meeting of the NNWPC, staff and DRI personnel presented a review of the Project. As part of the presentation, staff informed the NNWPC that six additional weather stations will be made available for use by the CSD. The NNWPC approved a motion to add six weather stations to enhance the Program's monitoring capabilities. Staff indicated that they would bring back a cost proposal for upgrading and installing the new monitoring equipment. At the NNWPC March 5, 2014 meeting, staff presented the following proposal which outlines the costs for the work related to the weather station upgrades and installations:

Staff and DRI have identified Lazy 5 Regional Park and Wilson Commons Park in Washoe Valley as ideal locations, and are in the process of evaluating four addition areas to situate weather stations for the Project. In addition to enhancing the Project, the data collected by the proposed enhancements will serve to provide the following benefits:

- The stations will become part of the Western Regional Climate Center monitoring network and will provided climate specific data for several hydrographic basins that will better define the microclimate conditions in the region.
- The identification, characterization and variability of microclimates can be used as a basis for creating better regulatory policies regarding landscaping requirements throughout the region.
- The data gathered can further be used to help calibrate downscaled global or regional climate and precipitation models to better help simulate observed local conditions.

FISCAL IMPACT

The fiscal impact to the RWMF, should this item be approved, will be \$40,000 in the fiscal year 2014/2015 budget. Fiscal year 2014/2015 budget authority will be located in Fund Group 766, Fund 7066, Account Number 710100, Professional Services, Cost Object WP310100.2.

RECOMMENDATION

Staff recommends that the NNWPC provide a recommendation to the WRWC to approve a First Amendment to the Interlocal Agreement with DRI to add \$29,050 in funding for upgrades and installation of weather stations; and, authorize the expenditure by staff of up to \$10,950 for services provided by other vendors for work related to the installation of weather stations.

SUMMARY

On April 7, 2014, the Northern Nevada Water Planning Commission ("NNWPC") received a proposal from Dr. Jeff Tilley of the Desert Research Institute ("DRI") to better quantify the benefits of the cloud seeding program by using additional precipitation gauges. The NNWPC directed staff to include \$25,000 for that purpose in the fiscal year 2014/2015 budget, which the Western Regional Water Commission ("WRWC") approved on May 15, 2014. The proposal contains two alternatives. The first proposal assumes the purchase and installation of two new precipitation gauges, and the second assumes that four existing precipitation gauges can be economically refurbished and relocated to sites identified in the proposal. The budget for DRI's costs in Alternative A is approximately \$25,000, and Alternative B is about \$23,000.

BACKGROUND

On November 6, 2013, the NNWPC approved a recommendation to the WRWC for an amount not to exceed \$100,000 from the Regional Water Management Fund ("RWMF") for the 2014/2015 cloud seeding program (the "Program"). During discussion on the Program, the NNWPC expressed a desire for DRI to better quantify the benefits of the Program. In the motion to recommend approval for funding, the NNWPC included a request for a proposal from DRI to further delineate and improve DRI's ability to measure increased snowpack resulting from the Program.

Beginning in 2009, the WRWC has helped pay for cloud seeding operations conducted by DRI and may anticipate continuing to partially fund the Program for the foreseeable future. Wintertime cloud seeding is focused on enhancing snowfall in mountainous regions to increase the snowpack, resulting in more spring runoff and water supplies in the surrounding areas. The DRI cloud seeding program has been in operation for more than 25 years. DRI estimates that, for the Truckee River Basin, cloud-seeding has boosted water in the snowpack by an average of 18,000 acre-feet a year over the last 10 years.

FISCAL IMPACT

The fiscal impact to the RWMF, should this item be approved, will be \$25,000 in fiscal year 2014/2015. Budget authority will be located in Fund Group 766, Fund 7066, Account Number 710100, Professional Services, Cost Object WP310100.3.

RECOMMENDATION

Staff recommends that the NNWPC provide direction to execute an Interlocal Agreement with DRI in an amount not to exceed \$25,000 from the Regional Water Management Fund for the supplementary precipitation gauges, following either Alternative A or Alternative B depending on final evaluation of the existing gauges.

SUMMARY

The purpose of this item is to provide a brief report on revenue and expenditure projections beyond fiscal year ("FY") 2014/15 and to discuss the need to make priority decisions in future budgets to bring expenses in line with projected expenses.

BACKGROUND

Since 2008, the Western Regional Water Commission's budget has included expenses that exceed annual revenue projections. This was possible because of adequate cash reserves. This year, a large portion of the cash reserves (\$2.7M) were obligated in an interlocal agreement for the acquisition of water quality water rights. That funding will likely be exhausted in FY 2014/15 and cash flow projections predict that cash reserves will be reduced to approximately \$300,000 on June 30, 2015.

Year by year, operating costs and certain project expenditures have been relatively stable while other project costs have varied. Considering past practices, this trend is likely to continue. In the future however, with the reduction in cash reserves, there will be less spending flexibility and a greater need to focus future budgets on priority activities.
