<u>DRAFT - MINUTES</u> NORTHERN NEVADA WATER PLANNING COMMISSION

Wednesday, June 1, 2016

The regular meeting of the Northern Nevada Water Planning Commission ("NNWPC") was held in the Washoe County Commission Chambers, 1001 East Ninth Street, Reno, Nevada and conducted the following business:

The meeting was called to order by Chairman Flansberg at 1:30 p.m.

1. Roll Call and Determination of Presence of a Quorum

Non-Voting Members Absent: My-Linh Nguyen, Harry Fahnestock, and Cindy Turiczek

Staff Members Present: Jim Smitherman; Chris Wessel; June Davis; and John Rhodes, Legal Counsel.

2. Public Comment

Cathy Brandhorst spoke on various topics.

3. Approval of Agenda (For Possible Action)

Jim Smitherman, NNWPC Water Resources Program Manager, stated that Item 10 is not required and can be removed from the agenda.

COMMISSIONER ERWIN MADE A MOTION TO APPROVE THE AGENDA, AMENDED AS REQUESTED STAFF, SECONDED BY COMMISSIONER PRICE. THE MOTION CARRIED UNANIMOUSLY WITH SEVEN (7) MEMBERS PRESENT.

4. Approval of Minutes from the May 4, 2016, Meeting (For Possible Action)

COMMISSIONER ERWIN MADE A MOTION TO APPROVE THE MAY 4, 2016, MINUTES, SECONDED BY COMMISSIONER DRINKWATER. THE MOTION CARRIED UNANIMOUSLY WITH SEVEN (7) MEMBERS PRESENT.

5. Presentation of the draft "Costs and Finance" chapter and fee burden analysis memo for the 2016 Regional Water Management Plan ("RWMP") update; discussion and possible direction to staff – Catherine Hansford, Hansford Economic Consulting. (For Possible Action)

Catherine Hansford presented the draft update of the Costs and Finance chapter and an overview of the cost burden analysis memo. Detailed information on this presentation is included in the staff report and PowerPoint presentation.

Commissioner Erwin stated that the analysis sets out that the divisor is the number of units and asked if it is possible to translate each of these into the number of people.

Ms. Hansford stated that Chapter 8 includes tables from the Truckee Meadows Regional Planning Agency that have the total number of units projected in each jurisdiction and the total

number of people but the costs are broken down by year. She asked for clarification if Commissioner Erwin is saying it would be helpful to see that on a per person basis.

Commissioner Price noted there are historical inaccuracies and grammatical errors in the chapter. Mr. Wessel stated that they will be going through the chapter to correct those errors once all comments are received.

9. Discussion and possible direction to staff regarding any chapters of the RWMP previously reviewed by the NNWPC in relation to the 2016 RWMP update – Jim Smitherman. (For Possible Action)

Mr. Smitherman reviewed revisions made to Chapter 5, Flood Management and Storm Water Drainage as directed by Chairman Flansberg at the May 4, 2016, NNWPC meeting. The revisions made are included in the staff report.

COMMISSIONER ERWIN MADE A MOTION TO ACCEPT THE REPORT, SECONDED BY COMMISSIONER SOLARO. THE MOTION CARRIED UNANIMOUSLY WITH SEVEN (7) MEMBERS PRESENT.

10. Review and possible approval of the WRWC Routine Operating Budget for non-staff services for Fiscal Year 2016-2017, and possible direction to staff – Jim Smitherman. (For Possible Action)
